What is quality child care?

Quality child care offers healthy social and educational experiences under qualified supervision in a safe, nurturing, and interactive environment.

Indicators of a Quality Child Care Setting:



Qualified Staff:

Meets required training and certification standards.



Positive Guidance:

Uses redirection and encouragement to support positive behavior.



Open Communication:

Provides regular updates and maintaining open feedback channels with parents.



Parental Involvement:

Encourages parents to participate in facility activities.



Structured Routine:

Follows a consistent daily schedule with balanced activities.



Safe Environment:

Maintains a clean, well-kept, and child-friendly space.



Age-Appropriate Activities:

Offers activities that support learning and development.



Staff-to-Child Ratio:

Meets or exceeds minimum staff-to-child ratio requirements.

General Requirements:

Every licensed child care facility must meet the minimum state child care licensing standards pursuant to s. 402.305, F.S., and ch. 65C-22, F.A.C., which include, but are not limited to, the following:

- ☐ Posts valid license for parents to see.
- ☐ Has Level 2 background screenings for all personnel.
- ☐ Maintains appropriate transportation vehicles (if transportation is provided).
- ☐ Provides written behavior guidance practices to parents.
- ☐ Provides appropriate access to the facility during normal hours of operation.

- ☐ Maintains minimum staff-to-child ratios:

Infant	1:4
1 year old	1:6
2 year old	1:11
3 year old	1:15
4 year old	1:20
5 year old and up	1:25



Physical and Quality Environment

- ✓ **Cleanliness:**
Keeps the space clean and free of hazards.
- ✓ **Inviting Space:**
Creates a welcoming, child-friendly environment that showcases children's work.
- ✓ **Safety:**
Ensures a safe and secure setting that supports children's independence.
- ✓ **Encouraging Play:**
Provides age-appropriate toys and materials that are easily accessible.
- ✓ **Positive Atmosphere:**
Fosters a warm, understanding, and responsive environment.
- ✓ **Stimulation:**
Supplies materials and experiences that spark curiosity and development.



Characteristics of a Quality Caregiver

- ✓ **Adaptability:**
Adjusts to different situations and children's individual needs.
- ✓ **Good Moral Character:**
Passes background checks, including history and screening for abuse or neglect.
- ✓ **Qualifications:**
Holds appropriate training and certifications in early childhood education.
- ✓ **Creativity:**
Engages children in interactive and educational activities.
- ✓ **Patience and Empathy:**
Responds to children's needs with patience, compassion, and stability.
- ✓ **First Aid and CPR Training:**
Is prepared to handle emergencies with basic first aid and CPR knowledge.
- ✓ **Communication Skills:**
Communicates openly and effectively with children and parents.
